Write a case brief on one of the following cases:

 a) Emilio Orlando et vs Victor Cassar decided by the Rent Regulation Board on the 27th November 2019 (Case Ref. 63/2015) by Magistrate Monica Vella;

OR

b) Boiken Cela vs Schembri Infrastructures Limited decided by the First Hall, Civil Court on the 5th April 2022 (Case Ref. 1187/2020TA) by Judge Toni Abela.

Question 3:

Complete both parts:-

a) Compare and contrast the sources of legal research (1,000 words);

AND

- b) Find the following:
 - Concurring Opinion of Judge Giovanni Bonello in the case of "Zarb vs Malta" decided by the European Court of Human Rights (4th Section) on 4th July 2006 (Application no. 16631/04);
 - ii. The "C" number of the company "Grifo Malta Limited". Is the company registered in the Insolvency Register? If in the affirmative, what is the date of the insolvency registration?;
 - iii. Ruling delivered by Parliament's speaker in the sitting held on 15th October 2008;
 - iv. Title of L.N 15/2016 and government gazette publishing number;
 - v. By virtue of which Act was Article 7(1) of Cap. 16 of the Laws of Malta amended?;
 - vi. The charges issued by the Police in the judgment "II-Pulizija vs Bogicevic Savo" decided by the Court of Magistrates (Malta) as a Court of Criminal Judicature dated 30th November 2021 (Reference number 548/2018);
 - vii. The title of Subsidiary Legislation 601.03;
 - viii. Minutes/ verbal dated 18th January 2022 of the case in the names "Saliba Spiridiona vs Vassallo Anthony et" (Ref 787/2021);
 - ix. (i) Title of EU Regulation 1215/2012 and (ii) Article 36 of the Regulation;

x. What was the legal instrument at the merits of the case "PL vs LL" decided by the Civil Court (Family Section) (Ref. 153/2019/3) on 18th December 2019?
