How Many First Aiders Do I Need??

• In Malta we have a legal requirement to have one first aider with every 100 employees in low risk areas. Two first aiders with every 50 employees are needed in high risk area. This is the law.

• The Law , like that of the GOOD SAMARATHAN Law (Namely Act XXIX of the 2020) civil and criminal code covers the First Responder



Assessment and Plan

- A first aid workplace needs assessment helps you as a business manager to identify your needs in terms of first aid cover required for your business.
- It is important to us that your course is not only suitable for your needs and legal requirements, but also tailored to your context, and therefore relevant to your staff.
- The results of the needs assessment are dependent on the degree of hazard, additional factors that could influence your overall first-aid provision, and the number of employees in your workplace.
